In the event that the Releases become involved in a charge, prosecution, civil litigation or any other legal proceeding under or related to the OHSA, arising out of or related to an act or omission of the Exhibitor, or the Exhibitor's violation of the OHSA, the Exhibitor agrees to be liable for, and to indemnify and pay the Releases' fine, penalty, costs, judgment, debt, damages, expenses and legal fees.
